The type of personal information we collect

We currently collect and process the following information:

How we get the personal information and why we have it

Most of the personal information we process is provided to us directly by you through:

For one of the following reasons:

- Provide you with a quality service.

We may share this information with professional service partners and organisations as required by law.

Under the General Data Protection Regulation (GDPR), the lawful bases we rely on for processing this information are:

- B. We have a legitimate interest.

How we store your personal information and for how long

Your information is securely stored on a password protected laptop and a password protected phone.

We will retain all of your information for the duration of our time working together.

Squarespace and Google analytics and cookies

This information may also include details about your use of this website, including clicks, internal links, pages visited, scrolling, searches, and timestamps. We share this information with Squarespace, our website analytics provider, to learn about site traffic and activity.

Your data protection rights
